# AMOUNT OF MONEY AND SOURCE:

# BACKGROUND/EXPLANATION:

In 1979, the City entered into the original lease with the Developer for a 75-year term, with a maturity date of August 1, 2054. The Developer pays to the City a Base Rent of \$0.67 per gross leasable sq. ft. plus Percentage Rent of 25% of net cash flow. 93.9% of the gross leasable area (149,066 sq. ft.) at Harborplace is leased in 2012. In the past five years (2007 - 2011), the City has averaged \$101,700.00 in annual Base Rent payments. The City has not earned any Percentage Rent under the Lease since its inception.

Under the third amendment to the lease, the City will extend the lease term for an additional 33 years, through 2087 which will reset the lease term back to the original 75 year term. In consideration of this lease extension, the Developer has agreed to undertake a significant capital improvement plan at Harborplace within 36 months after approval of the third amendment to the lease that includes the following improvements:

- a. replace exterior awnings,
- b. upgrade exterior lighting,
- c. upgrade exterior and interior lighting,

- d. screen and landscape along the street side of the Light and Pratt Street pavilions,
- e.upgrade, screen and landscape the Trash Compactor Room, and
- f.clean and repair all concrete surfaces on both the Light Street and Pratt Street pavilions and the Pratt Street pedestrian bridges.

Additionally, in consideration for the lease extension, the Developer has agreed to a fixed rent payment of \$262,500.00 per year with a 5% increase beginning in August 2022. The new rent payment is based on 7% of \$3,750,000.00, the fair market value of the City land at Harborplace, established by the June 2012 appraisal. The new Base Rent payment reflects a 158% increase over the average Base Rent earned by the City in the past five years. In 2054 (the first year of the lease extension under the third amendment to lease, the Base Rent will be adjusted and reset by a new appraisal, obtained by the City and the Developer.

# A LETTER OF PROTEST WAS RECEIVED FROM THE MARYLAND MINORITY CONTRACTORS ASSOCIATION, AND MS. KIM TRUEHEART.

<u>President:</u> "The first item on the non-routine agenda can be found on pages 3 to 4, Third Amendment to Lease Agreement. Will the parties please come forward? Good morning."

<u>Mr. Jenkins:</u> "Good morning, members of the Board. My name is Larry Jenkins from the City Law Department. The item before the Board is a request to amend the ground lease for Harbor Place, the Third Amendment and it's in response to a request from General Growth Properties, to extend the lease for a total of 75 years. The existing lease was signed in 2000, I'm sorry in 1979 went to 2054. It will now be extended until 2087. At the time of the request from General Growth Properties, the City secured an appraisal of the property meaning the ground because that's what we own, the buildings are owned by General Growth Properties, and based on the appraisal the value of the land was \$3,750,000.00 and using a 7% cap rate we arrived at a ground rent of \$262,500.00 per year. Under the existing lease, we're

getting about \$100,000.00 per year which would have gone down to \$88,000.00 in 2014. So, under this change we're going to be getting immediately the \$262,500.00 per year and then after the tenth year every five years it will increase by 5% and then it will reset, meaning based on the new appraisal and the value of the property in 2054 and continue after that. As part of the negotiations we also I guess got a promise from GGP to make certain capital improvements to the property which will improve it. Again, this is their building, the City is not in any way making any concessions as to, they are paying for it on their own. So, that would be request before the Board."

Mr. Jolivet: "Mr. President."

President: "Okay."

<u>Mr. Arnold M. Jolivet MMCA:</u> "Arnold Jolivet. When the uh -when this lease was originally structured and presented before the Board, and surprisingly I was here at the Board when it was, there was a provision in there surprisingly before we had the City's current MBE Policy but there was a provision in there for providing for participation of minority businesses in the Harbor Place as businesses. There was also a provision in there which

provided for minority contractors participation on a -- at the time they were actually constructing the project and they were not completely constructing it; but somehow or other when the lease was amended several years ago, that provision for some reason I believe was lost. But under the current City's MBE Policy and Ordinance I believe that it is appropriate for the City, this Board in approving this lease because there will be substantial capital improvements in Harbor Place over the years of the lease and I'm here early this morning to simply suggest or request your Honorable Board to see the propriety of incorporating our MBE Policy our WBE Policy into this lease as we move forward. I think it is a reasonable request. I just certainly don't think it's unreasonable and I wonder why the City doesn't do this on it's their own. I'm perplexed about it, but that's a different issue. So, I would urge this Board in its wisdom, I'm not opposed to the lease. I want the record to show. But in approving this lease which I think the Board would certainly be in their province to do, I would ask this Board to incorporate the City's MBE Policy as a part of this lease and that's a simple request Mr. President. Very extremely, extremely

simple and consistent with what we do now on other projects." Mr. Corey: "Good morning Mr. President, members of the Board. Thomas Corey, Chief of the Minority of the Women's Business Opportunity Office. As this third amendment to this lease is presently structured, the City is not providing any financial assistance to CGP. As such, the MBE/WBE law does not apply." Mr. Jolivet: "Mr. Corey normally comes up with that same argument. Uh, but Mr. President, it is really not about that, that's a technical -- that is actually a technical reading of the City's MBE Ordinance and I can find 50 lawyers who would differ with that. So, we're not it sounds like this is just an effort on the part of Mr. Corey not to comply or not to provide opportunities for our MBE/WBE community. But to say that it doesn't apply begs the issue. Totally begs the issue. He may be right, he may be wrong, but that's not the issue before this Board this morning. Nonetheless, I think I've made a very strong case that this is what we should be doing. When the program -- when Harbor Place was first initiated, it was built on land that was purchased with CDBG funds. So there should be

a clause in the lease agreement, a provision in the lease agreement because under the CDBG guidelines and under the Title VI, of 1964 Civil Rights Guidelines there is a provision which requires a non-discrimination clause to run with the land, and the City seems to have forgotten about that. Totally forgotten about it."

<u>Deputy City Solicitor:</u> "Excuse me, Mr. Jolivet, let me just ask you a question. Would uh - this proposed change, would you consider that to be a material change to the agreement originally structured back in 1979?"

<u>Mr. Jolivet:</u> "I would say yes, I could make an argument that it is. I certainly can make an argument that it is a material change. But nonetheless I'm not, I'm not I'm just not reading what you are inquiring about."

<u>Deputy City Solicitor:</u> "The reason I'm inquiring about that is because what you are proposing would require a brand new contract, and that is not something that is before the Board at this time. What's before the Board, at this time is an extension as Mr. Corey pointed out and I know that you differ but the MBE law does not apply. The City's receiving money here. The City is not giving any assistance. In fact the City is receiving, in 3718

my calculations, 122% more in rent than it previously did."

<u>Mr. Jolivet:</u> "That may be true, but keep in mind what you're missing and overseeing is that fact that the policy has also been that when there is construction going on City land and the development land development agreement is structured so that the City's MBE/WBE Ordinance can be incorporated into the land development agreement."

<u>Deputy City Solicitor:</u> "Sure, but let's be fair. This is not an LDA. This is an agreement that was back in 1979 and incorporated existing laws at the time. So, this is -- we're talking about apples and oranges here."

<u>Deputy City Solicitor:</u> "I would MOVE that the protest be rejected and that the bid be approved as recommended by the agency."

Dear Mr. President:

I represent the Maryland Minority Contractors Association, Inc. ("MMCA"), its members, clients and constituents. I wish to protest the following listed proposed lease or contract agreements contained in Your Honorable Board's 9-19-2012 public meeting agenda.

- (1) The third amendment to lease agreement with Harbor Place Associates, Limited Partnership, contained on pages 4-5. The proposed lease amendment violates the City's M-WBE Ordinance in its failure to incorporate such ordinance therein; and
- (2) Item No. 4 on page 15, which is a proposed non-bid, non-competitive \$297,500.00 contract with the Living Classroom Foundation, Inc., allegedly to provide certain ordinary services to the City designed to stop the killing occurring in Baltimore City and, if not possible to stop the killings in Baltimore City, to reduce the shootings and killings occurring n Baltimore city. Our protest is based on the fact that this proposed contract award violates Article VI, Section 11 et seq., of the City's Charter, and is ultra vires and void <u>ab initio; and</u>
- (3) Item No. 4 on page 15, which is a proposed non-competitive contract award to St. Ambrose Housing Aid Center, Inc., for \$322,380.00 to provide homeowners counseling. Our protest is based on the fact that the proposed contract agreement violates both the the City's competitive bidding charter provision, as well as the City's M-WBE Ordinance; and
- (4) Item No. 3 on page 41, which is a proposed federally funded grant agreement for the UMOJA Head Start Program. The City's MWBOO erroneously set the M-WBE goals at 27% MBE and 10% WBE respectively, and also incorrectly granted a partial waiver to the goals; and
- (5) The proposed Developers Agreement No. 1242-A, with Maryland Proton Treatment Centers, LLC. The DPW alleges that the City's M-WBE Ordinance does not apply to the subject agreement

because there is no City funds therein. However, both DPW and MWBOO completely overlooked the important and controlling fact that the development project is being constructed on a land site that was the subject of a City DHCD Land Disposition Agreement with the developer that specifically incorporated and made the City's M-WBE Ordinance bidding and applicable thereto; and

- (6) Item No. 18 on page 59, which is a proposed \$200,000.00 non-bid contract award to Clean Harbors Environment Services, Inc. pursuant to a cooperative contract with the Baltimore Regional Cooperative Purchasing Committee ("BRCPC"). Our protest is based on the fact that the proposed contract is nonetheless a clear violation of the City's "mandatory" competitive bidding charter provision, and is ultra vires and void <u>ab initio</u>; and
- (7) The proposed contract Item No. 9 on page 69, which is a propose \$300,000.00 contract award to Long Fence Company, Inc., for installation of fences for various City agencies. Our protest is based upon the fact that an African American firm was the low dollar bidder for the contract and pursuant to standard City MWBOO policy and practice, this African American bidder should have been provided with additional time (usually two weeks) in which to come into full compliance with the contract's set M-WBE goals. This clearly was not done and is a blatant case of unlawful racial disparate treatment for the African American firm and also violated the City's competitive bidding charter provision's mandate to award such contracts to the "lowest responsive and responsible bidder," as therein delineated.

Thank you for your kind and favorable consideration of these protests.

    - v. This Lease Agreement clearly demonstrates the inequity of outcomes historically negotiated by BDC, which routinely provides "give-a-ways" that benefit developers, NOT the City of Baltimore.

3. <u>How the protestant will be harmed by the proposed Board of Estimates' action</u>: As a citizen I am experiencing a significant financial burden with annual tax increases, sewer and water service increases, user fee increases, parking meter rate increases and significantly reduce services as a resident. This already onerous burden will be exacerbated by undisclosed material facts and details specific to this lease amendment with Harbor Place Associates Limited Partnership. The Baltimore City Solicitor MUST immediately act to stop and correct the HARM that has been done to the citizens of Baltimore City.

<u>Mr. Thomas Corey, MWBOO:</u> "It has been deferred. Good morning Mr. President."

<u>Mr. Corey:</u> "This is the Umoja Head Start Program which is essentially the same sort of arrangement as uh - the St. Ambrose Housing. It's a federal grant. We do take a look at it and place goals on it. In this particular instance after we excluded salaries, fringe benefits, rent, insurance and all of those items within its budget that cannot be subcontracted out, the balance we place goals on. In this particular instance

the balance amounted to something like \$59,183.00. We placed the maximum goals on that of 27 and 10, the Umoja Head Start Program exceeded the MBE goals that we placed on it and I believe the MBE participation that they achieved is \$152,676.00 of MBE participation and \$13,200.00 of WBE participation, so it's a win."

<u>Mr. Jolivet:</u> "Mr. President quite briefly to show you to illustrate how all of us and how arbitrary the goals setting process is, Mr. Corey set a goal under this project of \$59,000.00. This was his assessment to illustrate how arbitrary his assessment is, he sets the goal at \$59,000.00 when the contractor actually comes in with an actual achievement of \$139,000.00. So this tells me, Mr. Corey's goal setting process is just totally outrageous and it's not accurate."

<u>Deputy City Solicitor:</u> "Mr. Jolivet, but what is your protest?" <u>Mr. Jolivet:</u> "My protest is and I would like to use this protest to settle, if possible, a complaint that we've had with Mr. Corey's longstanding setting of the goals for these type of projects."

<u>Deputy City Solicitor:</u> "Mr. Jolivet, what is relevant to your protest here today not policies set by the Minority and Women Business Office. What is your protest for this?"

<u>Mr. Jolivet:</u> "I think I shared in my communication that Mr. Corey erroneously and improperly granted the waiver. There is no real case for a waiver here."

<u>Deputy City Solicitor:</u> "He just said that there were goals set on this and they were exceeded."

<u>Mr. Jolivet:</u> "Yeah but you didn't read the communication. That even after the goals were set there was still a request for partial waiver, point."

<u>Mr. Corey:</u> "Mr. President, members of the Board uh - the Head Start Program does request a waiver of all of those items which can't be subcontracted out. As I stated earlier salaries, fringe benefits, rent, telephone costs, utilities you can't sub those out, and so it's not fair to the recipient to include those in the goal calculation. The balance we did subject it to goal calculation and we applied the maximum goal allowed by this law, which is 27% MBE participation and 10% WBE participation."

Mr. Jolivet: "One final comment."

<u>Mr. Corey:</u> "Despite that, this program exceeded those amounts by at least three times."

Mr. Jolivet: "One final comment, Mr. President. I don't want to beat a dead horse, but I think it's the Ordinance requires the goals to be set to be established on the entire dollar value of the contract. Now, what Mr. Corey -- because the way Mr. Corey actually calculates the goal it gives the public an erroneous interpretation of what minority firms are getting. But to set them at 27 and 10, knowing full well that that is not an accurate amount is erroneous."

## BACKGROUND/EXPLANATION:

On April 9, 2008, the Board approved the agreement with the Baltimore Gas & Electric Company (BGE), setting rates to be paid for the use of the City conduit system. That agreement permitted the City to increase the rates one time during the term of the agreement, but not sooner than July 01, 2012 and by not more than 3%.

Inflationary costs associated with all City services, such as labor rates and other personnel costs, motor fuels, utilities, et cetera, have exceeded 3% in each of the four years since the BGE agreement was approved. In addition, the Department of Transportation has advanced a very aggressive capital program to replace critical sections of the conduit system to achieve a state of good repair. Therefore, the Department of Transportation, in consultation with the Department of Finance, believes it is appropriate to adjust the rates as follows:

The BGE agreement requires that the City notify BGE 30 days prior to proposed action by the Board on any rate increase. Notification was made by certified mail on April 9, 2012.

#### RATE FOR OTHER USERS & MUNICIPAL USERS

Except for BGE, the rate for all other system users will likewise increase from \$0.95 to \$0.9785 cents per linear foot. The Department of Transportation also proposes that the rate for street lighting cable be reduced to zero as the charge is paid to BGE and then charged back to the City. Eliminating fee this will reduce administrative costs on both parties and will have no net budgetary effect.

# Re: Department of Transportation Revised Schedule of Rates for the City's Conduit System; Item for Consideration at Board of Estimates' September 19, 2012 Meeting

Baltimore Gas and Electric Company (BGE) wishes to oppose the Baltimore City Transportation Department's (Department) request for a 3% rate increase to the rates to be paid by BGE for the use of Baltimore City conduit system. The issue presented is whether the increase is justified, as the Department claims, due to an increase in inflationary costs associated with City services, such as labor rates and other personnel costs, motor fuels, utilities. BGE holds that it is not justified.

Costs expended by BGE are ultimately recovered by BGE from its customers. Consequently, in the end, BGE's customers are negatively impacted by the City's rate increase. According to the Department's last audited financials, the Department underspent its budget on BGE conduit-related expenses by \$590,000 in fiscal year 2011. Due to the inability of the Department to use existing funds to its fullest potential, BGE questions of the Department whether a rate increase is truly warranted. In the April 9, 2012 notice, the Department notes that it is undertaking a "very aggressive capital program to replace critical sections of the Conduit system in order to achieve a state of good repair;" however recent history has revealed that the Department's expenditures have been lower than forecasted, which has led to funding not being used within the fiscal year, creating a credit during the reconciliation process. Thus, BGE's current rent is more than adequate to cover the expenses listed in the audited financials; therefore, an increase should not be needed.

BGE opposes the rate increase because it has an obligation to its customers to ensure BGE expenditures are prudent. In principle, BGE is not opposed to the Department spending to improve the conduit system if it benefits BGE customers. However, in this instance, since the City has not demonstrated the ability to spend BGE's allocation of existing funds; BGE cannot support, and indeed, must oppose, the Department's increase request because it unjustifiably adversely affects BGE customers' rates. Such an outcome is not in BGE customers' best Clerk Board of Estimates September 18, 2012 Page 2

interests. BGE respectfully requests that the Board deny the Department's rate increase. BGE will appear at the Board's September 19, 2012 meeting to articulate these concerns.

I represent the Maryland Minority Contractors Association, Inc. ("MMCA"), its members, clients and constituents. I wish to protest the following listed proposed lease or contract agreements contained in Your Honorable Board's 9-19-2012 public meeting agenda.

- (1) The third amendment to lease agreement with Harbor Place Associates, Limited Partnership, contained on pages 4-5. The proposed lease amendment violates the City's M-WBE Ordinance in its failure to incorporate such ordinance therein; and
- (2) Item No. 4 on page 15, which is a proposed non-bid, non-competitive \$297,500.00 contract with the Living Classroom Foundation, Inc., allegedly to provide certain ordinary services to the City designed to stop the killing occurring in Baltimore City and, if not possible to stop the killings in Baltimore City, to reduce the shootings and killings occurring n Baltimore city. Our protest is based on the fact that this proposed contract award violates Article VI, Section 11 et seq., of the City's Charter, and is ultra vires and void <u>ab initio; and</u>
- (3) Item No. 4 on page 15, which is a proposed non-competitive contract award to St. Ambrose Housing Aid Center, Inc., for \$322,380.00 to provide homeowners counseling. Our protest is based on the fact that the proposed contract agreement violates both the the City's competitive bidding charter provision, as well as the City's M-WBE Ordinance; and
- (4) Item No. 3 on page 41, which is a proposed federally funded grant agreement for the UMOJA Head Start Program. The City's MWBOO erroneously set the M-WBE goals at 27% MBE and 10% WBE respectively, and also incorrectly granted a partial waiver to the goals; and
- (5) The proposed Developers Agreement No. 1242-A, with Maryland Proton Treatment Centers, LLC. The DPW alleges that the City's M-WBE Ordinance does not apply to the subject agreement

because there is no City funds therein. However, both DPW and MWBOO completely overlooked the important and controlling fact that the development project is being constructed on a land site that was the subject of a City DHCD Land Disposition Agreement with the developer that specifically incorporated and made the City's M-WBE Ordinance bidding and applicable thereto; and

- (6) Item No. 18 on page 59, which is a proposed \$200,000.00 non-bid contract award to Clean Harbors Environment Services, Inc. pursuant to a cooperative contract with the Baltimore Regional Cooperative Purchasing Committee ("BRCPC"). Our protest is based on the fact that the proposed contract is nonetheless a clear violation of the City's "mandatory" competitive bidding charter provision, and is ultra vires and void <u>ab initio</u>; and
- (7) The proposed contract Item No. 9 on page 69, which is a propose \$300,000.00 contract award to Long Fence Company, Inc., for installation of fences for various City agencies. Our protest is based upon the fact that an African American firm was the low dollar bidder for the contract and pursuant to standard City MWBOO policy and practice, this African American bidder should have been provided with additional time (usually two weeks) in which to come into full compliance with the contract's set M-WBE goals. This clearly was not done and is a blatant case of unlawful racial disparate treatment for the African American firm and also violated the City's competitive bidding charter provision's mandate to award such contracts to the "lowest responsive and responsible bidder," as therein delineated.

Concrete General, Inc., is the responsible bidder submitting the lowest responsive bid in response to the Invitation to Bid for contract no. TR 12018. The purpose of this letter is to protest award of the Contract to any party other than CGI.

CGI were recently notified that our bid was found non-compliant. The City of Baltimore stated that the WBE we selected "M Luis Construction Company" is not certified with Baltimore City to perform work/service: "Provide equipment for Rehab" as CGI stated on the MBE/WBE Statement of Intent. Concrete General, Inc. disagrees with this decision.

CGI stated M Luis was 'providing equipment for Rehabilitation work' in your 'Brief Narrative Description of the Work/Service to be performed' on the MBE/WBE Statement of Intent. This was only supposed to be a brief description and not the exact description as stated on the form by the City of Baltimore. CGI did not know that the exact description of work/service should be listed on the form for MBE/WEB Statement of Intent. M Luis Is providing equipment services as a subcontractor for Rehabilitation work for Concrete and Asphalt Construction, and Bridge Work. This contract is for Structural Repairs on Bridges and M Luis is certified to perform concrete and asphalt construction and bridge work. This is exactly what M Luis Construction Company will be performing and CGI bid should not be found non-compliant.

The City of Baltimore must reject their decision of non-compliant on the grounds that it violates the Maryland Public Ethics Law. The City of Baltimore should award the contract to the responsible bidder submitting the lowest responsive bid that does not violate the Ethics laws; namely, CGI.

Dear Mr. President:

I represent the Maryland Minority Contractors Association, Inc. ("MMCA"), its members, clients and constituents. I wish to protest the following listed proposed lease or contract agreements contained in Your Honorable Board's 9-19-2012 public meeting agenda.

- (1) The third amendment to lease agreement with Harbor Place Associates, Limited Partnership, contained on pages 4-5. The proposed lease amendment violates the City's M-WBE Ordinance in its failure to incorporate such ordinance therein; and
- (2) Item No. 4 on page 15, which is a proposed non-bid, non-competitive \$297,500.00 contract with the Living Classroom Foundation, Inc., allegedly to provide certain ordinary services to the City designed to stop the killing occurring in Baltimore City and, if not possible to stop the killings in Baltimore City, to reduce the shootings and killings occurring n Baltimore city. Our protest is based on the fact that this proposed contract award violates Article VI, Section 11 et seq., of the City's Charter, and is ultra vires and void <u>ab initio; and</u>
- (3) Item No. 4 on page 15, which is a proposed non-competitive contract award to St. Ambrose Housing Aid Center, Inc., for \$322,380.00 to provide homeowners counseling. Our protest is based on the fact that the proposed contract agreement violates both the the City's competitive bidding charter provision, as well as the City's M-WBE Ordinance; and
- (4) Item No. 3 on page 41, which is a proposed federally funded grant agreement for the UMOJA Head Start Program. The City's MWBOO erroneously set the M-WBE goals at 27% MBE and 10% WBE respectively, and also incorrectly granted a partial waiver to the goals; and
- (5) The proposed Developers Agreement No. 1242-A, with Maryland Proton Treatment Centers, LLC. The DPW alleges that the City's M-WBE Ordinance does not apply to the subject agreement

because there is no City funds therein. However, both DPW and MWBOO completely overlooked the important and controlling fact that the development project is being constructed on a land site that was the subject of a City DHCD Land Disposition Agreement with the developer that specifically incorporated and made the City's M-WBE Ordinance bidding and applicable thereto; and

- (6) Item No. 18 on page 59, which is a proposed \$200,000.00 non-bid contract award to Clean Harbors Environment Services, Inc. pursuant to a cooperative contract with the Baltimore Regional Cooperative Purchasing Committee ("BRCPC"). Our protest is based on the fact that the proposed contract is nonetheless a clear violation of the City's "mandatory" competitive bidding charter provision, and is ultra vires and void <u>ab initio</u>; and
- (7) The proposed contract Item No. 9 on page 69, which is a propose \$300,000.00 contract award to Long Fence Company, Inc., for installation of fences for various City agencies. Our protest is based upon the fact that an African American firm was the low dollar bidder for the contract and pursuant to standard City MWBOO policy and practice, this African American bidder should have been provided with additional time (usually two weeks) in which to come into full compliance with the contract's set M-WBE goals. This clearly was not done and is a blatant case of unlawful racial disparate treatment for the African American firm and also violated the City's competitive bidding charter provision's mandate to award such contracts to the "lowest responsive and responsible bidder," as therein delineated.

Thank you for your kind and favorable consideration of these protests.
