This office represents the interests of Allan Myers MD, Inc. ("Allan Myers"), 2011 Belair Road, Fallston, Maryland 21047, an unsuccessful bidder on the above-referenced project ("Contract"). This letter serves as Allan Myers' formal protest of the award of the

Contract to the Renda/J Bros Joint Venture ("Joint Venture") in the amount of \$136,964,200.

As an examination of the bid submissions for this Contract demonstrates, Joint Venture's "low" bid was only 0.97% less than Allan Myers bid, a slim margin in terms of this multi-million dollar Contract. More importantly, Joint Venture has largely failed to comply with the Disadvantage Business Enterprises ("DBE") participation requirements set forth in the Contract Specifications. The Board should therefore rescind its award of the Contract to Joint Venture and award the Contract to Allan Myers, as it is the lowest *responsible* bidder. Any other decision would undermine the competitive process and the vital goals of the DBE Participation Program.

### I. <u>DBE Participation Requirements</u>

The DBE participation requirements under the Contract is clear. The MBE Goal is 18% and the WBE Goal is 16%. More importantly, each bidder is required to undertake certain <u>good faith efforts<sup>1</sup></u> to provide opportunities for DBEs to participate in the Contract, consistent with these goals, and the bidder must submit supporting documentation. These are not aspirational statements. Rather, the Specifications makes clear that "[p]erformance of the good faith steps <u>are</u> required, regardless of goal achievement." <sup>2</sup> If the City were to nevertheless award the Contract to a bidder who failed to perform these good faith steps, the City would be in violation of the requirements imposed on its use of the Maryland Water Quality and Drinking Water Revolving Loan Fund Program. Under such circumstances, the Environmental Protection Agency would be authorized to take remedial action against the award, including, among other things, suspending or terminating the award. See 40 C.F.R. §33.105(c).

### II. Joint Venture's bid fails to satisfy the DBE participation requirements as well as the overall DBE goals set forth under Federal and State regulations

Joint Venture, a partnership among two out of state companies, has fallen well short of the DBE participation requirements, and has done so to the detriment of the City of Baltimore and many local DBEs who are ready and able to participate in this Contract. Relying on supposed good faith efforts documentation that pales in comparison to that submitted by Allan Myers, <u>the Joint Venture is only willing to offer subcontracts to</u> <u>DBEs valued at 12.93%<sup>3</sup> of the Contract amount (comprised of 10% MBE participation and 2.9% WBE participation)</u>. This falls well short of the stated goals of 18% MBE and 16% WBE participation. <u>Allan Myers, on the other hand, as a local</u> <u>contractor committed to the City of Baltimore and its residents, is able to offer</u>

subcontracts to DBEs valued at 20.3% of the Contract amount (comprised of 15.5% MBE and 3.9% DBE). This amounts to approximately \$10.1 million in additional opportunities for Baltimore's DBEs, including DBEs located in empowerment zones. \$10.1 million that would be denied such entities if the out of state Joint Venture's bid is accepted by the City simply to achieve a meager savings of 0.97%.

Joint Venture may suggest that they did the best they could to meet the goals, and will point to their good faith efforts checklist in an effort to avoid confronting their shortcomings. Allan Myers submits that checking a handful of boxes does not make one the lowest, responsive and responsible bidder. Rather, the substance of the efforts, as revealed by the bid submission, should be evaluated in determining good faith efforts.

Moreover, Allan Myers has become aware that Joint Venture, despite receiving bids from local, qualified DBEs to perform various aspects of the Contract, elected not to use these DBEs. These DBEs include Brickhouse Brown Masonry and PMSI. They are all local DBEs who quoted the Joint Venture, and are all qualified and ready to perform. However, Joint Venture elected not to provide opportunity to these DBEs; and is instead carrying out the scopes with non-DBEs.<sup>4</sup> It is difficult to conclude how Joint Venture met its required good faith efforts when Allan Myers is able to offer an additional \$10.1 million in opportunity to Baltimore's DBEs while Joint Venture is ignoring DBEs who are ready and able to perform.

As the City is undoubtedly aware, it risks termination or suspension of the award or withholding of further awards if it were to give the Contract to a bidder that failed to meet its good faith effort requirements.<sup>5</sup> Here, the evidence points to only one conclusion – Joint Venture did not meet its good faith effort requirements, and such failure is material. Consequently, the City cannot award the Contract to Joint Venture. To do so is to ignore the express requirements of the Contract Specifications and to risk termination or suspension of the award by its federal funding source.

It also sends the wrong message to the contracting community about the importance of DBEs. Had Allan Myers understood that achievement of the DBE goals was not of paramount importance to the City, Allan Myers could have easily followed the Joint Venture's path, reduced the opportunities for Baltimore's DBEs, and offered a price lower than the Joint Venture. Surely, this is not what the City wants to encourage. It is certainly not what Allan Myers believes is right nor what the City has championed in the past.

Most recently, Allan Myers partnered with the City on the emergency contract for the Monument Street Emergency Repairs Project, successfully completing the contract ahead of schedule under extremely tough conditions. The Contract is for the project referred to as the Ashburton Zone 2 Tanks (the "Project").

As an examination of the Joint Venture's bid submission should demonstrate we believe that, the Joint Venture has largely failed to comply with the Disadvantage Business Enterprises ("DBE") participation requirements set forth in the Contract Specifications. This failure is material, and, as such, renders the Joint Venture's bid non-responsive. We are requesting that you consider the Joint Venture bid be found non-responsive. The Board should therefore reject the Joint Venture's bid and award the Contract to Allan Myers, as it is the lowest, responsive and responsible bidder. Any other decision would undermine the competitive process and the vital goals of the DBE Participation Program.

### I. The Joint Venture's Bid is Inherently Defective and Should Be Rejected.

The Joint Venture's bid fails to satisfy the DBE participation requirements set forth in the Specifications governing the Contract as well as the overall DBE goals set forth under Federal and State regulations. The Joint Venture's bid is therefore non-responsive and, per the very rules governing the Invitation for Bids, must be rejected.

The DBE participation requirements are clear. The MBE Goal is 18% and the WBE Goal is 16%. More importantly, each bidder is required to undertake certain <u>good faith efforts</u> to provide opportunities for DBEs to participate in the Contract, consistent with these goals, and the bidder must submit supporting documentation. As I'm sure you are aware, the EPA's "The Six Good Faith Efforts and Contract Administration Requirements" under the EPA's DBE program are required methods implored by all EPA financial assistance agreement recipients to ensure that all DBEs have the opportunity to compete for procurements funded by EPA financial assistance dollars". The Six Good Faith Efforts are:

- 1) Ensure DBEs are made aware of contracting opportunities to the fullest extent practicable through outreach and recruitment activities. For Indian Tribal, State and Local and Government recipients, this will include placing DBEs on solicitation lists and soliciting them whenever they are potential sources.
- 2) Make information on forthcoming opportunities available to DBEs and arrange time frames for contracts and establish delivery schedules, where the requirements permit, in a way that encourages and facilitates participation by DBEs in the competitive process. This includes, whenever possible, posting solicitations for bids or proposals for a minimum of 30 calendar days before the bid or proposal closing date.
- 3) Consider in the contracting process whether firms competing for large contracts could subcontract with DBEs. For Indian Tribal, State and local Government recipients, this will include dividing total requirements when economically feasible into smaller tasks or quantities to permit maximum participation by DBEs in the competitive process.
- 4) Encourage contracting with a consortium of DBEs when a contract is too large for one of these firms to handle individually.
- 5) Use the services and assistance of the SBA and the Minority Business Development Agency of the Department of Commerce.

6) If the prime contractor awards subcontracts, require the prime contractor to take the steps in paragraphs (a) through (e) of this section. What are the New Contract Administration Requirements?

These same "Efforts" apply to the State's MBE program as well, as required and stated under the Maryland Water Quality & Drinking Water Revolving Loan Fund Programs DBE Guidance for Loan Recipients, Prime Contractors, and Subcontractors:

Steps 1 & 5 can be achieved by developing a bidders list of qualified DBE firms that can bid as prime contractors or as subcontractors. Loan recipients, prime contractors, and subcontractors (if they further subcontract) should advertise in minority, local and regional newspapers. Loan recipients can also advertise in the Dodge report. Loan recipients should provide their bidders list to prime contractors, who can supplement this list with their own bidders list.

Information for developing bidders list of qualified DBE firms for participation as prime contractors or subcontractors in construction, equipment, services, and supplies, should be gathered from different resources (see Appendix C, below), such as

- Loan recipient (for prime contractors)
- Maryland Department of Transportation (MDOT) <u>http://www.mdot.state.md.us/MBE\_Program/Index.html</u>
- U.S. Small Business Administration (US-SBA) https://www.sba.gov/offices/district/md/baltimore
- Minority Business Development Agency (MBDA) of the US Department of Commerce <u>www.mbda.gov/</u>

Steps 2, 3, & 4 can be achieved during the project planning, design, and/or pre-bidding phase, to assure that qualified DBE firms have procurement opportunities in construction, equipment, services, and supplies.

The following steps need to be undertaken:

- Conduct pre-bid meetings to inform potential bidders/contractors about DBE requirements and provide guidance in undertaking the required good faith efforts.
- Use the bidders list developed in Item A (above) to solicit DBE firms as prime contractors or subcontractors.
- Invite DBE firms, where appropriate, to meetings, conferences, etc., to inform them of procurement opportunities and develop, where possible, reasonable contract and delivery schedules that encourage and facilitate participation by DBEs. This includes allowing a minimum of 30 calendar days for bids or request for proposals.
- Determine if a project can be broken down into smaller components/contracts to allow opportunities for DBE firms to bid both as prime contractors and subcontractors.
- For projects broken down into smaller components (e.g., painting, roofing, excavation, pipe laying, etc.), ensure that the delivery schedules are reasonable.

- Encourage DBE firms, where appropriate, to apply as a consortium of DBEs, when a contract is too large for one of these firms to handle individually.
- Loan recipient must require prime contractor to complete EPA forms 6100-4 and 6100-3 and submit with bid proposal.

Loan recipients (step 6) must require the prime contractor to undertake steps 1 through 5 as a good faith effort in providing DBE firms opportunities as subcontractors by including the MDE Insert/Requirements and Contract Provisions for utilization of DBEs in the bidding documents (Emphasis provided).

Here, the Joint Venture, a partnership among two out of state companies, has fallen well short of the DBE participation requirements, and has done so to the detriment of the City of Baltimore and many local DBEs who are ready and able to participate in this Contract. Relying on supposed good faith efforts documentation that pales in comparison to that submitted by Allan Myers, the Joint Venture is only willing to offer subcontracts to DBEs valued at 12.9% of the Contract amount (comprised of 10% MBE participation and 2.9% WBE participation). This falls well short of the stated goals of 18% MBE and 16% WBE participation. Allan Myers, on the other hand, as a local contractor committed to the City of Baltimore and its residents, is able to offer subcontracts to DBEs valued at 20.3% of the Contract amount (comprised of 15.5% MBE and 3.9% DBE). This amounts to approximately \$10.1 million in additional opportunities for Baltimore's DBEs, including DBEs located in empowerment zones. \$10.1 million that would be denied such entities if the out of state Joint Venture's bid is accepted.

The Joint Venture may suggest that they did the best they could to meet the goals, and will point to their good faith efforts checklist in an effort to avoid confronting their shortcomings. Allan Myers submits that checking a handful of boxes does not make one the lowest, responsive and responsible bidder. Rather, the substance of the efforts, as revealed by the bid submission, should be evaluated in determining good faith efforts.

As noted above, the Joint Venture has fallen well short of the amount of opportunity Allan Myers is able to offer Baltimore's DBEs - \$10.1 million short. Allan Myers also has evidence that the Joint Venture, despite receiving bids from local, qualified DBEs to perform various aspects of the Contract, elected not to use these DBEs. These DBEs include Salute, Brickhouse Brown and PMSI. They are all local DBEs who quoted the Joint Venture, and are all qualified and ready to perform. However, the Joint Venture elected not to provide opportunity to these DBEs; and is instead carrying out the scopes itself or with non-DBEs. We are hard-pressed to see how the Joint Venture met its required good faith efforts when Allan Myers is able to offer an additional \$10.1 million in opportunity to Baltimore's DBEs and the Joint Venture is ignoring DBEs who are ready to perform.

As the City is undoubtedly aware, it risks termination or suspension of the award or withholding of further awards, if it were to give the Contract to a bidder that failed to meet its good faith effort requirements.<sup>2</sup> Here, the evidence points to only one conclusion – the Joint Venture

did not meet its good faith effort requirements, and such failure is material. Consequently, the City cannot award to the Joint Venture. To do so, is to ignore the express requirements of the Specifications and to risk termination or suspension of the award by its funding source.

We have never failed to finish a project for the City. We have never been declared in default. And, we certainly have never abandoned the City. Most recently, Allan Myers partnered with the City on the emergency contract for the Monument Street Emergency Repairs Project, successfully completing the contract ahead of schedule under extremely tough conditions. On the Monument Street project, Allan Myers worked around the clock within a congested urban environment to repair a storm sewer failure that had caused a large sinkhole. <u>President:</u> "The first item on the non-routine agenda can be found on pages 50 - 51, items 1 - 2, Department of Public Works, Recommendations for Contract Awards/Rejections, WC 1211, Ashburton Reservoir Zone 2 Tanks. Will the parties please come forward? Okay. State your name."

<u>Mr. Jay Price:</u> "Good morning, I'm Jay Price. I'm the Acting Bureau Head of Water and Waster for the Department of Public Works. It's our recommendation, we move forward with award Water Contract No. 1211 to Renda/J. Bros. Joint Venture."

<u>Mr. Lorenzo Bellamy:</u> "Good morning, Lorenza Bellamy on behalf of Alexander & Cleaver. Um -- I'm also here on behalf of Allan Myers. Ah -- protesting the recommended award."

<u>President:</u> "Um -- you going to tell us what your protest is based on?"

<u>Mr. Bellamy:</u> "Mr. President, Mr. Hammen, Comptroller Pratt, good morning, Members of the Board, good morning. I'm Lorenza Bellamy, again, with Alexander & Cleaver on behalf of Allan

Myers. We are protesting, ah -- this award, um -- for several reasons. Mainly, we believe that the recommended awardee did not meet the good faith test in order to find qualified and certified MBEs. Ah -- first I want to just go through, very quickly, the dollar figure that's at stake here. This is a hundred -- the -- the -- the bid is \$136,964,000.00. Allan Myers bid is \$137,777,000.00, a difference of 0.97%. Renda's MBE numbers are 10.1%, WBE 2.92% or 12.93% total. Allan Meyer's WBE is 15.5% and WBE 3.9% ah -- 9% or 19.4%. In terms of dollar value, \$10.1 million more for MBE companies than the recommended awardee. I think if we are to look at the -- the policy Mr. President and members of the Board, you all have stated on many occasions whether its been before this Board, whether its been um -- before the press, whether its been in Court, that MBE issues are critical and important to -- to this Board and also to the citizens of Baltimore. Had we, Allan Meyers, decided to go below -- either below ah -- what we submitted then I think

that we would have had obviously had won -- won this bid. And, I think that ah -- but then at the expense of who, at the expense of MBE Certified Baltimore City MBE Companies. And, I think that you all have said that you want to support MBE Companies in Baltimore City. The Maryland Department of the Environment came up with um -- the recommendation to award this contract to Renda. In their April 4, 2017, letter, I'm not sure if you have that, and I can provide you with a copy, they basically recommended the award saying that um -- they were the responsible bidder, but they didn't indicate anywhere in the letter whether or not good faith efforts were -- were made to -to find MBE ah -- companies that least come close to the 34% that ah -- the goal that was established by -- by this um -- by the -- by the RFP. And, so MBE didn't even come up with a rationale as to why in good faith they thought Renda should be given this award. The Environmental Protection Agency has what we call and it's in my -- in my -- in it's -- it's part of the attachment to the protest. They call it the Sixth -- the Sixth

Good Faith Efforts in Contract Administration Requirements. And, I'm not going to go through all six of them. You can look at that and see what they are. And, I would submit that -- that Renda did not meet any of those ah -- six requirements, but, that my client, Allan Myers has. The argument may be made that Renda went through a checklist and checked off boxes that indicated that they made good faith efforts. I would submit that just simply checking off boxes is not necessarily a good faith effort. I have with me -- is Brick House here? Can you come up please, sir? We have two -- two MBEs, one that's here and state your name for the record please."

<u>Mr. Wilbur Brown:</u> "Um -- Wilbur Brown, I'm representing Brick House Brown Masonry."

<u>Mr. Bellamy:</u> "They're one of the MBEs that, ah -- submitted ah -- to ah -- Renda. Renda chose not to use them which is in their right ah -- to do that. This is a certified MBE Company that and that there's a letter attached to ah -- to -- to my protest that indicates what they tried to do. Ah -- they are certified ready

and available DBE/MBE ready to do business. Ah -- you know, we -- we used them. We had them on our list. And these are in addition to -- to these two companies, ah -- these are companies that were -- that are based in Baltimore City that some of them are actually in Empowerment Zones. So, we are supporting the policy that the City of Baltimore has recommended for using MBEs in this -- in this -- in these type of contracts. And, so I just -- I hope, um -- Mr. President and Members of the -- of the Board that you would -- you would look at the numbers here. We're talking of the difference of 0.97%. You know, we came in at 27, um -- million for MBE. They came in at 17 ah -- million. That's 10 mil -- 10.1 million, as I stated before for MBE Companies. And, I think that, you know, when you look at the policy behind this, I think it's very important to - to -- if this was a significant difference I could see where you would say well, what's in the best interest of the City? What's in the best interest of the, um -- of the residents of Baltimore City?

And, I think best interest and I've seen this at State level and at -- and here in this Board before this commit -- this -- this -- admit - this um-- um -- this Board -- you have, you have stated on a many occasions what is in the best interest and have ruled what is in the best interest of this City even if there have been discrepancies in -- in price or even in MBE qualifications. And I would say here, the best interest of this City and the best interest of this Board, and you represent the citizens of Baltimore would be to award this to -- to my client Allan Myers, especially given the MBE requirements and the MBE goals that they have established, um -- in this contract. And finally I would say um-- my recommendation would be that you would ah -- reject the recommendation of the Board of Public Works, sorry of the, of the Public Works Department and that you would um -- award it to Allan Myers. Alternatively, we'd ask that you throw out the bid completely and re-do this, paying careful attention to the good faith efforts of um -- of -- of

all the bidders lets say, but specifically Allan Myers and perhaps even Renda on MBE qualifications, on an -- on an MBE spin. Ah -- with that I turn it over to -- Nunzio, you have anything you want to add?"

<u>Mr. Nunizo Ruggeri:</u> "Good morning Members. My name is Nunizo Ruggeri. I'm General Counsel for Allan Myers. Rich and I ah --Rich is the Executive Vice-President of Construction at Allan Myers. We've had the opportunity to be uh -- part of the City of Baltimore for a significant period of time. Rich, in particular, has been here since roughly 2002?"

Mr. Ruggeri: "2002."

<u>Mr. Rich Dungan:</u> "We've had many occasions where we've seen this Board make decisions that are in the best interest of the City. Here's one of those situations for you. You have an opportunity to provide an additional \$10 million of opportunity to very, very important residents of this community. If you choose our bid, that's what you get. If you don't choose our bid, that \$10 million does not materialize. Thank you for your time. I appreciate it."

President: "Um -- even though, I -- I don't agree with the whole process. Um -- but, this is a State, um -- um -- issued contract. Um -- you guys are still not the lowest bidder. Um -you come in at 138,298,777 and they come in at 136,964."

Mr. Bellamy: "That's correct."

President: "200 --"

Mr. Bellamy: "I stated that, Mr. President that we are .097% off."

President: "Right. Okay. Any -- anybody else?"

Comptroller: "Let me ask you a question? Did um -- the joint venture meet the DBE requirements?"

Mr. Ruggeri: "No."

Mr. Bellamy: "I can speak to what the joint venture -- you said they didn't?"

Mr. Ruggeri: "They -- right -- they - they -- with respect to the requirements our position is they -- they haven't because of the good faith efforts requirements. So, to answer your questions specifically ah -- Mr. Young, if the -- the -- the difference in price makes no meaning -- has no difference at this point because we would say that they not responsive or responsive."

<u>Interim City Solicitor:</u> "Ah -- let me just ask one question. Ah -- actually two questions just to confirm. So, you're not the lowest bidder, but you're position is you -- you were responsive and they were not responsive? But, th -- in the State contract, the State found that they were responsive. Isn't that correct?" <u>Mr. Bellamy:</u> "That is correct. But, I would -- I would -- I would argue that their rationale for finding that they were responsive was arbitrary and capricious. I think that there was no -- there was no good faith attempt. There was no rational basis between their number, the MBE search, and the good faith to the actual award."

<u>Interim City Solicitor:</u> "And -- and Mr. Bellamy what do you base this arbitrary and capricious decision on?"

<u>Mr. Dungan:</u> "Excuse me, if I might. My name is Rich Dungan, the -- ah -- I'm the one that signs the contracts. I've been in the bid room with ah -- Allan Myers ah -- since 2002 bidding work for the City. This project's going to be worth \$138 million and

Renda and Johnson Brothers Joint Venture committed to 12% minority participation, Allan Myers has 20%."

<u>Interim City Solicitor:</u> "I don't -- I don't mean to cut you off. But, I do. Wha -- what is the answer to my question?"

Mr. Bellamy: "Well --"

<u>Mr. Dungan:</u> "The answer is that in the past the City has never gone ahead with any of the -- any of these bids with just 12% participation."

<u>Interim City Solicitor:</u> "No, my question is; 'what is the basis for your statement that the State's decision was arbitrary and capricious?'"

<u>Mr. Bellamy:</u> "Solicitor Ralph, let me try to answer that question for you. So, in Natural Resources versus US 5686 the Federal sec -- ah -- F  $2^{nd}$  um -- the  $9^{th}$  Circuit Case, '92 Case. It stated that the absence of a rational connection -- I'm just going to read this -- connection between the facts found and the

choice made. A clear error of judgement, I would say there was a clear error of judgement with the State. An action not based upon consideration of relevant factors and so is arbitrary capricious and abuse of discretion or otherwise not in accordance with the law or if it was taken without observance of procedure required by the law. And, I would say that on its face -- I mean just looking at the -- our bid and the numbers and who we use, our good faith efforts to try to find qualified WBE --WBE and MBE companies versus the other side. I would say on its face, without even having to go in through the -- and -- and I know it's hard to prove arbitrary and capricious, but I would say on its face based on those numbers alone that one can make that -- that -- that assumption."

<u>Interim City Solicitor:</u> "Okay, two things and I'll -- I'll end. One, I -- I do want to commend ah -- Allan Myers for working as hard as it did. Ah -- in -- in trying to get subcontractors for this contract. Um -- but, just because you were able to do more doesn't mean that the other bidder didn't do -- make good faith

efforts to ah -- obtain them. You -- you -- you got more and I commend you on that. But, to say that -- that difference that delta ah -- and the State's decision to find that delta ah -not ah -- good faith and that it -- its decision to do so arbitrary and capricious, I think is -- is -- is a leap, a far leap."

<u>Mr. Bellamy:</u> "If I -- If I may um -- Solicitor, I would ah -- I would say that, um -- you know -- in a -- in a real world and looking at -- you know, just the law ah -- on its face, perhaps you're right. But, if you look at the numbers that they actually presented when you go to good faith, the difference between 12.93 and almost 20% and so thir -- lets say 13% and 20% that is -- that is a significant gap. If the numbers were closer, I would say yes. Then it would be hard to -- potentially hard to make that argument. But, because the gap is so great and the difference action in the price, when you look at the price .97% on a \$136, \$137 million contract. So, I would say yes, sure they -- they may have um -- met -- actually the goal was 34%. So, I

mean, I would argue that, you know, you should throw this whole thing out and actually start over again so that we can actually do better. But, I would say that the actual -- when you look at the -- the difference between their number and our number, I would say on its face and I'll continue to make that argument -that - that uh -- they were not exercising good faith."

<u>Ms. Erin Sher Smyth:</u> "Good morning. Erin Sher Smyth for Department of Finance, City Purchasing Agent. Ah -- the Board --Bureau of Purchases recommends a denial of the protest as the protestant was found non-compliant by MWBOO. However, we have discussed this with the using agency, the Department of Housing, and this is a multiple award with the intention to award to as many responsive vendors as possible. Ah -- there were two bidders that were found responsive, yet non-compliant and we would recommend that the protest be denied. However, both ah -the Bureau of Purchase -- sorry -- the Board of Estimates allow the Bureau of Purchases to reach out to both non-compliant vendors and allow them to correct their forms and submit to

MWBOO for compliance finding. If they are found compliant at that time, we would return to the Board of Estimates with additional award recommendations so that the Department of Housing has the additional resources for this important program. Thank you."

Comptroller: "So, that means they will become a part of this contract?"

Ms. Sher Smyth: "Yes."

Comptroller: "-- that's being awarded."

Ms. Sher Smyth: "They will be added to this contract."

Comptroller: "Added to this? Okay."

Ms. Sher Smyth: "Correct."

Interim City Solicitor: "Question, how many -- how many um -contractors can be a part of this?"

Ms. Sher Smyth: "There is no limit to the number of contractors. Eight bidders ah -- submitted bids, five are recommended today, one was found non-responsive and two were found non -- they were found responsive, yet, non-compliant."

Ms. Ruth Ann Norton: "Good morning. Um -- thank you for the opportunity to be before you. I'm Ruth Ann Norton. I'm the President and CEO of the Green Healthy Homes Initiative. I'm joined by Larry Brown who is our Crew Chief on the Lead Hazard Control ah -- Program and Wes Stewart, who's our in-house Counsel. Um -- ours is a simple error. Ah -- we had a -- we have ah -- we were the lowest, responsive bidder ah -- for the ah -public bid for Lead Hazard Control, a service that we have provided to the City of Baltimore since 1994. Ah -- we have ah we hire uh -- from impacted communities and provide full wage jobs with health insurance benefits, retirement and, ah -- other benefits and uh -- including training and career paths. I think we are the only bidder uh - that does that. Um -- our work has been ah -- noted by the U.S. Department of Housing and Urban Development for our hous -- for our lead hazard control work. Um -- and I'll let Larry speak uh -- on that. Basically, here we had a uh -- MBE subcontractor, New Century uh -- who we missed

the fact that they are also a WBE and they circled WBE and so, when we turned in the forms I signed an affidavit that we did meet the 27% and 10% requirements ah -- because we were counting New Century in the MBE category. Um -- by the -- by the fact that that was signed ah -- circled WBE that we missed in our ah -- review which is our fault. Um -- the positon that I have -- I have been there 15 years. Um -- started my first two years at AmeriCorp and when I started at AmeriCorp, I was also part of the Lead Hazard Control Team. Um -- after my two years of completion of AmeriCorp, lead to employment with working for Green & Healthy Homes, and at the time of my employment I had no training. So, the -- it -- the um -- Green & Healthy Homes organization has helped me with training. Um -- I contribute to my 403(b). Um -- earn a nice wage salary and also um - I'm one

of five members who also lives in the community. Um -- we love working in the community. I think we have a big impact, based on providing the services, and then a lot of the families have questions for us, and then we also can call the coalition which is the formerly Green & Healthy Homes and um -- provide them with, you know, with lawyers, rent court. So, not only, um -- do I feel our abatement -- our lead hazard work is very important, but also how the organization has in a -- in a circle have other sources to help families. So--."

Comptroller: "That's good."

<u>Ms. Norton:</u> "And, I -- um nice to see you Mr. Billups. I want to just reiterate that in our um -- my signing that affidavit on behalf of our organization; so, I also own the mistake of our oversight of the circle. Um -- but, if you count New Century in the MBE category, we will exceed the 27% and still meet the WBE. Um -- so I just want to ah -- put that on the record and we're happy to answer any of the questions and ask for your consideration."

President: "Um -- well, you said you made a minor mistake?" Ms. Norton: "But, we didn't -- Council President, our mistake in our review is although we signed the affidavit at 27% and 10% because we counted New Century in the MBE category which they are and we checked this morning they are a certified MBE uh -and remain so for the City. They are also a WBE. We put them in that category. What we -- the oversight on our part was that they circled WBE on their forms. So, rightfully, when it got to Mr. Billups shop, they went solely by the forms submitted by the subcontractors and counted them in the category by which they circled, I think. Is that a correct?
