Re: Public Information Act Fulfillment Report November 23, 2023 through January 24, 2024

Starting November 2023 all Public Information Act requests sent to the to the Baltimore City Office of the Comptroller are published in a report and made available quarterly on the office's website.

The Comptroller's Office committed to this level of transparency in its January 2021 transition report (pg 26).

This policy includes all Public Information requests from the media, public, business and government entities, and cover all available responsive documents from the departments of the Office of the Comptroller and adjourned Board of Estimates meetings.

Please note, requests for background documentation for Board of Estimates meetings will not be included in these reports. Those requests are handled internally in the interest of expediency and transparency, with a simple review from Law and Comptroller staff, so that the information can be shared within 24 hours of the request.

This is the first report. It covers November 23, 2023 through January 24, 2024. The next report will be released in May 2024.
