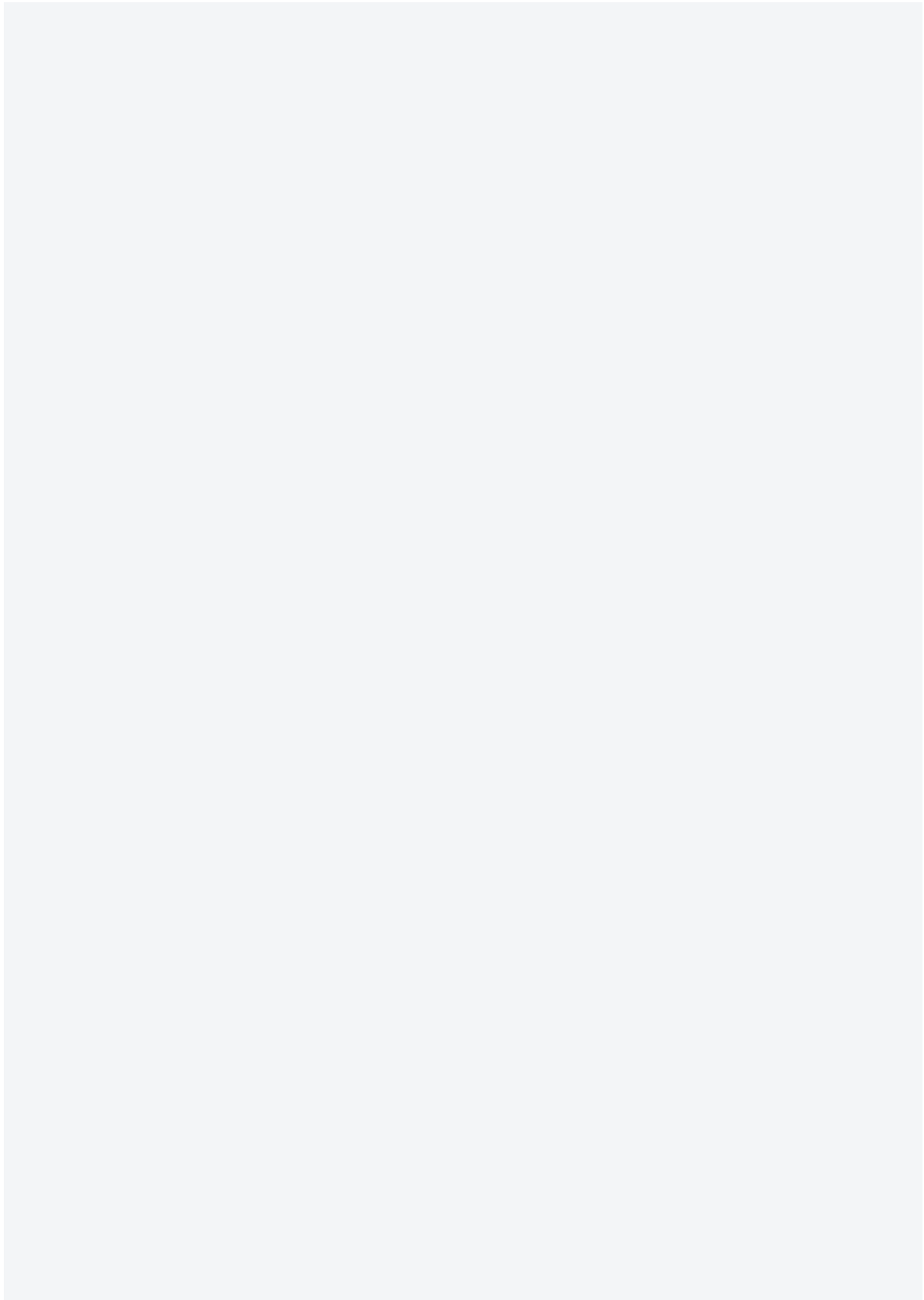

BACKGROUND/EXPLANATION:

On April 14, 2021, the Board approved an initial award with Selex ES Inc. with two 1-year renewal options. Subsequent actions as shown in the Contract Value Summary below.
