

**SB-24-11520 - Correction -- Custodial Groups 1 and 2 from A.B.S II Enterprise to Golden Gate Service Inc.**

The Board is requested to approve a Correction to SB-23-14559 Award of RFQ-000285 Janitorial and Cleaning Services to A.B.S II Enterprises and Golden Gate Service Inc. Period of agreement is: 4/17/2024 to 12/31/2027

**BACKGROUND/EXPLANATION:**

This correction strikes the following language: The Board is requested to approve a goods and services contract award (to vendors) - ASB2 Enterprises Inc (Group 1 to 2) and Golden Gate Service Inc (Group 4 to 10) and INSERT: The Board is requested to approve the award of a goods and services contract with Golden Gate Service Inc for Group 1 to 10.

This item has been presented as a walk on due to the necessity to continuity of services in these public buildings.

The Department of General Services (DGS) through the Bureau of Procurement (BOP) invited bids for janitorial and cleaning services to the general public on Tuesday, July 25, 2023. The purpose of this action was to receive and evaluate bidders who would offer optimal level of janitorial and cleaning services (i.e., lowest responsive and responsible bidders) at various City's buildings.

A total of twelve (12) bids were received and opened on September 20, 2023. The bids were evaluated to determine whether they were responsiveness and responsible. Two (2) bids were determined to be non-responsive because the bidders did not submit "MBE & WBE Participation and Commitment Forms" along with their bids. In furtherance, the Mayor's Office of Small and Minority Business Advocacy and Development (MSMBAD) determined that only two (2) bidders of the ten (10) bids were in compliance with predetermined MBE & WBE goals.

The contract awards were made by the BOE to A.S.B.2. Enterprises Inc. and Golden Gate Services, Inc on December 20, 2023. However, the BOE memo under the "action requested" stated: "The Board is requested to approve a Goods and Services Contract Award (2-Vendors)-A.S.B.2

Enterprises Inc. (Group 1 to 2) and Golden Gate Service, Inc. (Group 4 to 10)." This requested action was an error. The memo should have read "The Board is requested to approve a Goods and Services Contract Award (2-Vendors)-A.S.B.2 Enterprises Inc. (Group 1 to 3) and Golden Gate Service, Inc. (Group 4 to 10)." Currently, A.S.B.2. Enterprises Inc. has communicated its inability to perform janitorial and cleaning services at various locations (Group 1 to 3) that were awarded by the BOE. The BOP along with DGS have decided to award Group 1 to 3 to Golden Gate Service, Inc. as the next ranked responsive and responsible bidder. This decision was taken to ensure the continuation of services performance at these locations.

The above amount is the City's estimated requirement; however, the vendors shall supply the City's entire requirement, be it more or less.
